**12.11.01 APPROVAL OF THE AGENDA**

The Speaker informed Senate that the agenda requires an amendment to allow for the approval of new senators. He asked for a motion to amend the agenda.

#### **12.11.04.03 Curriculum Committee – motions**

**Moved (Burnett/Ridout): that Senate approve the following new course as submitted by the Department of English:**

**ENGL 2706 Biography: Writing Lives**

*This course will examine biography, a popular, influential, and yet, understudied genre of literature. Students will explore forms of narratives based on real lives by reading a selection of representative books on a range of persons (i.e. artists, authors, musicians) written during different historical periods. Essays on the genre will also be used to illuminate its aims and significance. No pre-requisite. (lec 3) 3 cr*

- Meetings were held this week with officials at SKG in an effort to expand ANIS programming. Some progress has been made aimed at finalizing an agreement.
- The mayor of Brockville, ON has contact Algoma indicating interest for block programming as a feeder system for upper year programming at the main campus.
- The visits to North University of China and the University of Jinan in early November were quite successful with the signing of 2+2 agreements with each institution in the area of Computer Science. Thanks for the work of Dr. Simon Xu and David Marasco on the agreements.
- Renovations to the faculty lounge are complete.
- A successful convocation ceremony was held in Brampton in late October. Former premier Bill Davis gave the convocation address.

**12.10.07 DISCUSSION AND QUESTION PERIOD**

Schantz addressed concerns with some of the academic challenges international students were facing this term. He informed Senate that work is currently underway with programming to assist students for academic preparedness. He added that the faculty are attempting to accommodate a variety of international student skill sets in an effort for them to succeed.

The situation requires additional support systems to have the students accumulate the requisite knowledge/skill sets including analytical skills. Some students are struggling in remedial courses offering significant challenges which will affect their academic progression. A university foundation program will allow these students the necessary skills in identify the gaps and meet the needs of the students. There is an immediate need to be addressed and the faculty have been very supportive in the transition program. The program will provide for a creative learning environment.

With respect to the curriculum of the foundation program, the process will follow the current senate approvals and will ensure that academic programs are not comprised during the approval process.
